1 On March 18, 2008, the Court held a hearing on the Independent Plaintiffs' Motion to  
2 Compel Deposition Dates by Coral Energy Resources, L. P. The parties appearances are as noted

4 case, the Court made the following order:

5 1. By Friday, March 21, 2008, Coral will provide Plaintiffs with deposition dates

8 Management Conference, at which time the following will take place:

12 2008 hearing should be prepared to tell the Court when the Court can set a

- 14 c. At the time of the last date for Defendants to provide their deposition  
15 schedules, or at or about that time, the Court will set a further Case  
16 Management Conference, to set a discovery cut-off date, trial readiness  
17 conference, and a trial date, etc.

18 IT IS SO ORDERED.


