**TERMS AND CONDITIONS FOR A TELEPHONE APPEARANCE**

1. Eligibility for a telephone appearance is not available if the applicant has been ordered to personally appear at the hearing.
2. The court has discretion to permit a telephone appearance if it is appropriate, or to deny the request if it determines that a personal appearance would materially assist in the determination of the proceedings or the effective management or resolution of the case.

3. At any time during the telephone appearance, the court may determine that a personal appearance is necessary, continue the matter, and require a personal appearance.
4. Information to verify your identity over the telephone must be provided upon the court's request.
5. Procedures for a telephone appearance may vary among the different departments. It is the party or attorney's responsibility to know and comply with these departmental procedures.
6. The court will try to accommodate unexpected problems associated with a telephone appearance; however, absent good cause, the matter may proceed without the applicant's appearance or a continuance, and the court may decide the matter based on the information and evidence before it.
7. An appearance by telephone does **not** relieve a party or attorney of any obligations otherwise associated with a personal appearance, including the timely filing, service, and lodgment of all documents.
8. An appearance by telephone does **not** grant a party or attorney any additional rights otherwise not associated with a personal appearance, including the opportunity to inspect documents or evidence properly submitted by another party and the ability to see all nonverbal aspects of the hearing.
9. A request to appear by telephone must be filed with the court and served on all parties at least ten (10) court days before the scheduled hearing date.
