**The plaintiff must file the claim in the proper court and geographical area.**

This court is the proper court for the trial of this case because it is:

- a. (1) Where a contract (written or spoken) was made, signed, performed, or broken by the defendant or where the defendant lived when the defendant made the contract. (2) Where the defendant lives or does business. (3) Where the plaintiff's property was damaged. (4) Where the plaintiff was injured.
- b. Where the plaintiff signed the contract or lives (or lived) if this claim is about an offer or contract for personal, family, or household goods, services, or loans. (Code Civ. Proc. § 395(b))
- c. Where the plaintiff signed the contract or lives (or lived) if this claim is about a retail installment contract (like a credit card). (Civ. Code § 1812.10)
- d. Where the plaintiff signed the contract or lives (or lived) if this claim is about a vehicle finance sale. (Civ. Code § 2984.4)
