## San Diego Superior Court Reduces Public Business Hours

As a result of reduced funding, the San Diego Superior Court is reducing its public business office hours beginning **Monday, December 1, 2008**.

The current state budget has resulted in reduced funding for many state services, agencies and even the judicial branch. In response to this budget crisis, the San Diego Superior Court has worked diligently over the past year to meet the needs of court users and litigants while reducing expenses to stay in line with our authorized level of funding. One of the ways the court has responded to the new budget reality is to reduce the number of court employees by not replacing those who have retired or left the court workforce. “With fewer employees to handle the work of the court, and backlogs growing in many areas within the clerks’ offices, the court must take steps to balance the time it is open to the public with its need to provide the clerical time needed for necessary document processing that must occur to move cases through the court system in a timely manner. Given the fiscal reality facing the court, we must reluctantly reduce our public service hours by one hour a day,” says Michael Roddy, Executive Officer of the San Diego Superior Court.

Although the court is faced with this difficult decision to reduce public business office hours, it is continuing to develop new online services to provide easier and better access to current and

additional court services. New services available through the Superior Court website, [www.sdcourt.ca.gov](http://www.sdcourt.ca.gov), give court users the ability to:

- Pay a traffic ticket, sign up for traffic school, or request an extension
- Pay court-ordered fines or fees
- Look up information on court cases using our Case Search lookup, Register of Actions, Court Calendar, Civil & Probate Law and Motions Page or New Case Filings
- Look up jury service information or request an extension
- Access quick links to Child Support, DMV, Sheriff's Warrant and Restraining Order indexes
- Access information to help guide one through court locations and services

In addition to these online services, all court locations provide drop boxes where court filings can be deposited before 5:00 p.m. and will be considered filed that business day.

The court appreciates the patience and support of its court employees and court users as it continues to search for innovative ways to provide court services to both the legal community and the public.
