San Diego Superior Court Spotlights Mediation Week

March 15-21, 2009

The Judicial Council of California has designated the third week in March as Mediation Week, and the Superior Court of San Diego County is joining associate courts and other organizations around the state to increase public awareness of the availability and benefits of court mediation programs.

Mediation is a form of alternative dispute resolution (ADR) in which a neutral third person helps the parties reach a voluntary resolution of a dispute. Mediation is less formal than traditional court proceedings and helps people resolve civil, family, juvenile matters, and other matters in a less adversarial setting. Studies have shown that court mediation programs save the parties time and money, improve satisfaction with the courts' services, and reduce future disputes and offenses.

California Superior Courts increasingly encourage and offer mediation for a broad range of issues and case types. The San Diego Superior Court formerly participated in a mandatory pilot mediation program. It currently offers a voluntary civil mediation program and facilitates a small claims mediation program, in addition to providing mediation services for child custody and visitation disputes.

- Child custody and visitation mediation; and
- DRPA (Dispute Resolution Programs Act) community mediation services.

In addition, a video monitor linked to the court's website will enable people to view a short mediation video in either English or Spanish. Milica Novakovic, the Court's Mediation Program Coordinator; Karen Thompson of North County Lifeline; and court staff will be present to answer questions and to further inform the public about the mediation process and the various mediation services offered.
