San Diego Superior Court Improves Computer Access to Case Information

Register of Actions (ROA) Now Provides More On-Line Information

San Diego Superior Court customers can now see more information on certain case types without coming to the courthouse via the court's website: www.sdcourt.ca.gov. The court's On-Line Services section of the website provides more information on case activity or case *Register of Actions (ROA)* for Civil, Small Claims and Probate cases filed after January 1, 2008.

Since 2008, the public has been able to view activity in Civil, Small Claims and Probate cases; however, the information provided was limited. Working with the San Diego legal community, the court has added improvements to the service to help attorneys, self-represented litigants and other interested parties get their needed information on-line and not spend time in line at the courthouse.

In addition to information on filings and hearings, the upgraded ROA now provides:

- Ability to view the ROA at no cost in a printer-friendly version.
- Ability to purchase PDF documents generated from the court's case management system.
- Contact information (address and phone numbers) for attorneys and self-represented litigants.
