Ι. **GENERAL COMMENTS:**

The SDPD Southern Division does not conduct secure detentions of minors. During 2012, there were no non-secure detentions at or over 6 hours for any minors.

Logs related to minors are maintained via electronic documentation and are not separated based on WIC 300/777 and WIC 601/602 designations.

It appears that 157 minors were subject to non-secure detentions for under 6 hours, with the longest detention lasting 298 minutes (<5 hours). At least 7/157 were classified as WIC 300 or 777, with one youth detained in March that was not clearly specified but was released to Polinsky.

Minors and adults are brought in and processed in the same area of the Police Department, although a separate, open and glass front cell is available to hold minors. No signs were posted informing minors of their rights.

П. **RECOMMENDATIONS** (if any):

-Separation of WIC 300/777 and WIC 601/602 youth in the electronic log books is recommended.

-Signs should be posted and visible informing minors of their rights during detention. An example of appropriate signage was provided to the Southern Division SDPD.

Note: The policy reported to the Commissioner and noted in the Procedures and Policy manual is that youth are released to paramedics when they are found to be under the influence of intoxicating substances and not brought to the station. However, according to their electronic log, in June 2012 at least one minor was brought in on a "Drunk in Public" charge and there was no notation about whether or not medical clearance was obtained. No other details were documented and no explanation was provided to the Commissioner about why this happened. It is unknown if other intoxicated minors were brought in so VII. B. cannot be accurately answered at this point.
