### **New Grand Jury Selected**

San Diego County has a new Grand Jury. Nineteen San Diegans were sworn in on Tuesday to serve on the 2005-2006 County Grand Jury. The jury members were randomly drawn from a field of 113 qualified, interested citizens. The jurors represent each of the five Districts in the County. Judge Kenneth So administered the oath to the new Grand Jury members on June 28 in the Presiding Department of the Central Courthouse downtown.

The 2005-2006 Grand Jury will begin its one year term of service on July 1 and will serve as a "people's panel" to evaluate citizen complaints, guard the public interest and serve as a "watchdog" over governmental affairs.

After interviewing all interested members of the 2005-2006 Grand Jury, Presiding Superior Court Judge John Einhorn has announced the selection Mr. James Vlassis, a retired high school principal, as this year's Grand Jury Foreman.
