### Annual Youth in Court Day Spotlights Perils of Teen Prescription Abuse

North County High School Seniors will come face to face with the dark realities of prescription drug abuse at the 12<sup>th</sup> annual "Youth in Court Day" at the North County Division of the San Diego Superior Court. Seniors will hear from a family whose son was permanently damaged from abusing the drug Oxycontin. The presentation is one of several programs held on March 8, 2013 at the Superior Court in Vista.

"Youth in Court Day" is a nationally acclaimed program designed to teach students about the law, the justice system and to expose them to law enforcement job opportunities. During the daylong event, students will personally observe the court system and see the real tragedies and real-life scenarios that move through the court.

The highlight event for high school seniors will take place at 12:45 p.m. in the Vista Courthouse Jury Lounge. Sherrie Rubin of the H.O.P.E Foundation will talk with the Seniors about her family's plight. Sherrie's son, Aaron nearly died of a prescription drug overdose and is now a quadriplegic (see attached). Aaron will also participate in the presentation.

"The morning session gives younger students personal exposure to and experience with the workings of our jury system. The afternoon session puts seniors eyeball to eyeball with people who have faced real life challenges, some of which had unpleasant outcomes. Television and the media cannot fairly replicate what the students will experience at Youth in Court. The

school systems do not provide an equivalent experience or learning tool," says Superior Court Judge Richard Cline who created the program.

Organized by the North County Bar Association, the North County Lawyer Referral Service, along with Superior Court judges and staff, Youth in Court Day provides morning mock trials for elementary and middle school students and educational workshops for high school students on diverse topics such as gangs, drugs, domestic violence, and the potential hazards of social networking.

The mock trials will start at 9:00 a.m. and 10:30 a.m. The educational sessions begin at 1:00 p.m. and 2:00 p.m. "Youth in Court Day" has attracted more than 10,000 students since its inception. The Vista Superior Court collaborates on this project with attorneys of the North San Diego County Bar Association. Youth in Court and related outreach programs have garnered local, county, state and national awards for the two organizations.

Sherrie Rubin / H.O.P.E.

Sherrie and Michael Rubin's son, Aaron, overdosed on oxycontin October 9th, 2005. He laid three and a half weeks in a coma, on life support. They began planning their son's funeral when, against all medical odds, he began to open his eyes. Aaron survived, but the overdose has left him a quadriplegic and unable to speak.

In 2009 Sherrie began speaking at schools warning students/parents about prescription medications, drugs and the deadly "**REAL**" consequences that can occur by misusing and abusing these drugs.

On November 24th, 2010 Sherrie and her husband Michael founded, The H.O.P.E. Foundation, a 501 (c) (3) non-profit foundation. Sherrie is the executive director. The H.O.P.E. Foundation provides prescription medication and drug abuse presentations independently, and jointly, with the Sheriffs Department, The DEA, The San Diego Prescription Pill Task Force, both public and private coalitions.
