NOTICE OF FEE CHANGES EFFECTIVE JANUARY 1, 2020

The court's Fee Schedule (SDSC Form #ADM-001) has been amended to reflect twenty-two increased fees pursuant to Assembly Bill 330 (Stats. 2019, ch. 217), which are summarized below.

All changes are effective January 1, 2020.

The following fees increased from \$25 to \$40:

- Line 72: Issuing writ of attachment, writ of mandate, writ of execution, writ of sale, writ of possession, writ of prohibition, writ of restitution, or any other writ for enforcement of an order or judgment. [Gov. Code §70626(a)(1)]
- Line 73: Issuing abstract of judgment. [Gov. Code §70626(a)(2)]
- Line 78: Certificate of satisfaction of judgment (CCP 724.100). [Gov. Code §70626(a)(3)]
- Line 94: Writ of execution. [Gov. Code §70626(a)(1), Code Civ. Proc. §116.820]
- Line 95: Abstract of judgment. [Gov. Code §70626(a)(2), Code Civ. Proc. §116.820]
- Line 182: Certifying a copy of paper, record, or proceeding on file (copy fees not included). [Gov. Code §70626(a)(4)]
- Line 183: Certificate for which fee is not otherwise fixed; includes lis pendens (copy fees not included). [Gov. Code §70626(a)(8)]
- Line 200: Taking affidavit, except in criminal case or adoption proceedings. [Gov. Code §70626(a)(5)]
- Line 201: Acknowledgment of deed or other instrument. [Gov. Code §70626(a)(6)]
- Line 202: Recording or registering license or issuing certificate in connection with a license, required by law, for which charge is not otherwise prescribed. [Gov. Code §70626(a)(7)]
- Line 220: Certifying a copy of a paper, record, or proceeding on file (copy fees not included). [Gov. Code §70626(a)(4)]

- Line 30: Filing and entering award under Workers' Compensation Act. [Gov. Code §70626(b)(6)]
- Line 31: Application for subpoena for discovery in out of state case (CCP 2029.300). [Gov. Code §70626(b)(5)]
- Line 69: Confession of judgment (CCP 1134). [Gov. Code §70626(b)(3)]
- Line 70: Renewal of judgment (CCP 683.150). [Gov. Code §70626(b)(4)]
- Line 74: Issuing an order of sale. [Gov. Code §70626(b)(1)]
- Line 160: Affidavit procedure for real property of small value under Prob. C 13201. [Gov. Code §70626(b)(9)]
- Line 178: Appeal from determination of dangerous or vicious dog (F&A 31622). [Gov. Code §70626(b)(8)]
