Code, § 528.5</li> <li>Falsely personating as described in Pen. Code, § 529</li> <li>Telephoning, including, but not limited to, making annoying telephone calls as described in Pen. Code, § 653m</li> <li>Destroying personal property</li> <li>Contacting, either directly or indirectly, by mail or otherwise</li> <li>Coming within a specified distance</li> <li>Disturbing the peace of the other party</li> <li>Coercive control of the other party.
