**ORDER NO. 050620-49**

18 Due to the life-threatening COVID-19 pandemic, the Governor of California has declared  
19 a state of emergency in this state. The President of the United States has also declared a national  
20 emergency. In response to the pandemic, the court has been closed to the public except for  
21 specified time-sensitive and essential functions. (See General Orders of the Presiding  
22 Department, Ord. Nos. 031820-34, 040320-39, and 043020-47.) All matters not deemed time-  
23 sensitive and essential that were scheduled on and between March 17, 2020, and May 22, 2020,  
24 have been continued and will be reset. (*Id.*) In addition, all days on and between March 17,  
25 2020, and May 22, 2020, have been deemed holidays for purposes of computing time for filing  
26 papers under Code of Civil Procedure §§ 12 and 12a. (*Id.*)


27 For Good Cause, and pursuant to the Court's inherent and supervisory authority, and the  
28 Presiding Judge's duty to take into account the needs of the public and Court as they relate to the

1 efficient and effective management of the Court (Cal. Rules of Court, rule 10.603), this Court  
2 **HEREBY FINDS AND ORDERS AS FOLLOWS:**

3 In all criminal cases in which the Court ordered a defendant to enroll in or complete the  
4 Public Service Program (PSP) (a.k.a. Public Works), Probation shall extend the enroll-by date  
5 and/or proof of completion date 90 calendar days from the previous enroll-by or proof of  
6 completion date. The extensions granted herein only apply to enroll-by and proof of completion  
7 dates that would have otherwise expired between March 17, 2020, and May 22, 2020, inclusive.

8 IT IS SO ORDERED.
