The Court, having examined into the facts and circumstances, finds that:

- Before the parties marry, they must participate in the counseling prescribed by Section 304 of the Family Code.
- Before the parties establish a domestic partnership, they must participate in the counseling prescribed by Section 297.1 of the Family Code.

The Court finds that there  is  is not evidence of coercion or undue influence on the minor(s).

The Court finds that the above-named persons  should  should not be allowed to marry or establish a domestic partnership.

The Court finds the minor(s) received the information described in Family Code section 297.1(g) or Family Code section 304(e).
