This year's theme for the national celebration is: *Liberty Under Law: Empowering Youth, Assuring Democracy*. The San Diego Superior Court, joined by the San Diego County Bar Association, the North County Bar Association, the Foothills Bar Association, and the San Diego County Public Law Library, is hosting a number of events.

"Law Week gives us an excellent opportunity to reach out to the community, show the public how the court works and how to access the justice system," says Presiding Superior Court Judge Janis Sammartino.
