San Diego Superior Court Judge Christine K. Goldsmith Retires

Judge Christine K. Goldsmith, admired for her legal acumen and exemplary judicial demeanor, is leaving the San Diego Superior Court Bench after serving more than 27 years as a judge. Appointed to the El Cajon Municipal Court in January of 1987 by Governor George Deukmejian, Judge Goldsmith served as the Presiding Judge of that court in 1991. In 1998, she joined the Superior Court upon court unification.

Judge Goldsmith has served with distinction in both the East County Branch and Downtown. Her most significant contributions have been in criminal assignments and ultimately in the Family Courts. Always known as a quick study, she brought a significant criminal law background to her initial Family Court assignment and excelled. She has garnered recognition for her work receiving awards from the San Diego County Family Law Specialists (San Diego County Outstanding Judicial Officer of the Year - 2008) and the Southern California Chapter of the Academy of Matrimonial Lawyers (Distinguished Jurist Award - 2003 and 2012).

Judge Goldsmith began her legal career with Defenders Inc. in San Diego (1977 to 1978) and then move into private practice, first as an associate with the Law Offices of John A. Mitchell (1978-1979) and then as a sole practitioner in El Cajon (1979-1984). In 1984, she joined the San Diego District Attorney's office where she prosecuted both misdemeanors and felonies (1984-1987).
