I understand the possible punishment and consequences of my conviction of the offense to be:

<b>SENTENCES FOR DRIVING IN VIOLATION OF A LICENSE SUSPENSION, REVOCATION, OR RESTRICTION</b>		
<b>VEHICLE CODE SECTION</b>	<b>FIRST OFFENSE</b>	<b>SECOND OR SUBSEQUENT OFFENSE: PRIOR CONVICTION(S) IN PAST 5 YEARS OF SECTIONS 14601, 14601.1, 14601.2 or 14601.5**</b>
14601	5 days to 6 months in jail, and a fine of \$300 to \$1,000	10 days to 1 year in jail, and a fine of \$500 to \$2,000. 10 days in jail minimum if probation is granted.
14601.1	Up to 6 months in jail, or a fine of \$300 to \$1,000, or both	5 days to 1 year in jail, and a fine of \$500 to \$2,000.
14601.2*	10 days to 6 months in jail, and a fine of \$300 to \$1,000. 10 days in jail minimum if probation is granted.	30 days to 1 year in jail, and a fine of \$500 to \$2,000. 30 days in jail minimum if probation is granted (10 days if within 7 years of a prior offense).
<i>*If I have been designated as a habitual traffic offender within three years of this conviction, I will be sentenced to serve an additional 180 days in jail consecutive to any other sentence, and pay a \$2,000 fine.</i>		
14601.5	Up to 6 months in jail, or a fine of \$300 to \$1,000, or both.	10 days to 1 year in jail, and a fine of \$500 to \$2,000. **Section 14601.3 also constitutes a prior conviction for this offense.
<b>VEHICLE CODE SECTION</b>	<b>HABITUAL TRAFFIC OFFENDER</b>	<b>SECOND OR SUBSEQUENT OFFENSE: PRIOR CONVICTION(S) IN PAST 7 YEARS OF SECTION 14601.3</b>
14601.3	30 days in jail, and a fine of \$1,000	180 days in jail, and a fine of \$2,000
<b>VEHICLE CODE SECTION</b>	<b>SENTENCE FOR CAUSING INJURY WHILE DRIVING WITH A LICENSE SUSPENDED OR REVOKED PURSUANT TO 14601.2</b>	
14601.4	Shall be imprisoned in county jail and shall not be released upon work release, community service, or any other release program before the minimum period of imprisonment prescribed in 14601.2 is served. (See chart above.) If probation is granted, shall serve at least the minimum time of imprisonment as specified under 14601.2 as a term or condition of probation.	

1. I have read and understand the minimum and maximum sentences listed in the above chart.  1.
2. (If applicable) I understand that in addition to any other penalty for driving with a suspended or revoked license, the Court may impound my vehicle for an additional six months for a first conviction, or up to 12 months for a second or subsequent conviction (VC § 23592).  2.
3. I understand that a vehicle registered to me may be forfeited if I have a prior conviction of VC §§ 12500(a), 14601, 14601.1, 14601.2, 14601.3, 14601.4 or 14601.5, and if I thereafter drive that vehicle while I have no license, or while it is suspended or revoked (VC § 14607.6).  3.
4. I understand that upon a conviction of VC § 14601.2, or upon a plea of guilty or nolo contendere to §§ 14601, 14601.1, 14601.4 or 14601.5 when 14601.2 was the original charge, the Court shall require me to install a certified ignition interlock device on any vehicle I own or operate for up to 3 years (VC § 23575). Installation of this device does not authorize me to drive without a valid license.  4.
