 - FOURTH AMENDMENT WAIVER:** Submit person, vehicle, residence, property, personal effects, _____, (including computers, cell phones, or other devices storing electronic information) to search at any time with or without a warrant, and with or without reasonable cause, when requested by a law enforcement officer.
 - Not knowingly possess any weapon, firearm, replica firearm or weapon, body armor, ammunition, or any instrument used as a weapon.
 - Pay \$ _____ diversion restitution fee (Pen. Code, § 1001.90).
 - Pay victim restitution of \$ _____ to CA Victim Comp. Board (Rest. Fund) to victim _____ (claim # _____) Plus \$ _____ to victim _____ (claim # _____) Plus \$ _____ to victim _____ (claim # _____), plus 10% annual interest on unsatisfied amount (Pen. Code, §§ 1001.96, 1202.4(f)(3)(G)).
