Having considered the facts presented and good cause appearing, the Court orders that the above-named child be referred to Voices for Children, Inc. for appointment of a Court Appointed Special Advocate.

IT IS FURTHER ORDERED THAT:

1. _____ is appointed as a CASA for the above-named child;
 (Name)
2. Said CASA will have access to the child and to the records and files of the court, of the County of San Diego Health and Human Services (HHSA) and Probation Department, and of any school; hospital, doctor, therapist or other individual or agency regarding the above-named child. This order includes all paper and electronic records including Justice Electronic Library System (JELS), and a copy of this order will be the only authorization necessary for such purpose;
3. Said CASA will not disclose the information received to anyone other than the assigned probation officer, social worker, attorneys, or the court unless specifically authorized by the court;
4. Said CASA will be given notice of, and be authorized to attend all conferences and/or court hearings regarding this child;
5. Said CASA will receive all reports from the HHSA and/or the Probation Department at least 48 hours prior to court hearings;
6. Said CASA will, in coordination with the other parties, investigate and report to the court such information as will assist this child in obtaining a permanent home;
7. Said CASA may, upon suspension of parents' educational rights, if said CASA is willing and able, serve as parent surrogate for educational purposes pursuant to Gov. Code section 7579.5(c);
8. All of the above work will be under the general supervision of Voices for Children, Inc.; and
9. This appointment will be in full force and effect until further order of the court.
