- You are requesting that a two-page Probate Mediator Profile containing your contact information and mediator profile information be included in binders at various court locations to be made available to litigants by the San Diego Superior Court, Probate Division, pursuant to Cal. Rules of Court, rule 10.781. Your Probate Mediator Certification and Release of Liability form will not be included in the binders, but will be kept on file by the court.
- You are releasing the Superior Court of California, County of San Diego and its employees, agents, and assigns from any liability or damage which may result from furnishing any of the information displayed in your profile or requested in the certification.
- You are agreeing to serve as a mediator on a pro bono basis for at least one case per year, not to exceed eight hours.

Note:

- Your profile may be temporarily or permanently removed from the binders at any time at the sole discretion of the court without cause and without notice to you.
- If you fail to submit a completed Probate Mediator Profile and Probate Mediator Certification and Release of Liability form on a bi-annual basis, your profile *will* be removed from the binders without notice.
